Carroll County Health Department Board of Health Briefing Paper May 16, 2024

Issue: Bureau of Prevention, Wellness, and Recovery Briefing

Background:

1) Executive Order 01.01.2023.21

The Senior Opioid Group (Opioid Intervention Team - OIT) was established under Governor Hogan's Executive Order in 2017 along with the Opioid Operational Command Center (OOCC). With the new executive order in December 2023, the OIT is now the Opioid Prevention Team (OPT), and the OOCC has become Maryland's Office of Overdose Response (MOOR), reflecting an updated mission and scope to address the overdose crisis more broadly.

At the state level, Special Secretary Emily Keller now leads MOOR and reports to the MDH Secretary and the Governor. The Maryland Overdose Response Advisory Council takes the place of the Inter-Agency Heroin and Opioid Coordinating Council and will be chaired by the Lt. Governor.

2) Opioid Prevention Team (OPT) structure

OPT members include representatives from partner agencies in health, social services, education, public safety, and other community and faith-based organizations as well as harm reduction, treatment, and recovery programs. It is co-chaired by CCHD and a community partner. The OPT must meet quarterly and comply with the Open Meetings Act in order to receive funding from MOOR. OPT also keeps a county program inventory spreadsheet.

OPT workgroups include the Opioid Prevention Coalition, Nicotine and Tobacco Prevention Coalition, the Local Overdose Fatality Review Team, the Suicide Prevention Coalition, and the Cannabis Coalition.

3) Opioid Prevention Coalition and Opioid Misuse Prevention Program

The Opioid Prevention Coalition meets bimonthly. It is funded by the Opioid Misuse Prevention Program (OMPP), which is awarded to local health authorities to implement evidence-based prevention and intervention strategies for the general population and people who are at increased risk of misusing or already misuse opioids. Strategies for FY 25-26 include safe storage and disposal of medications, public safety training, and academic detailing with clinicians to impact opioid prescribing.

4) Substance use and misuse prevention in schools

The Health Department provides and supports a range of substance use and misuse prevention programming in local schools. CCHD partners with CCPS to offer the evidence-based suicide and substance use prevention program Sources of Strength in all middle and high schools. Prevention Office staff work with CCPS to ensure that middle and high school health class presentations complement the current curriculum and provide interactive, skill-building information to enhance protective factors. CCHD partners with CCPS and the Carroll County State's Attorney to offer the "Don't Believe the Lie" assembly for 7th graders that reinforces refusal skills and healthy alternatives.

5) Continuum of Care and Residential Treatment in Maryland

The continuum of care for substance abuse includes early intervention, outpatient services, intensive outpatient services, partial hospitalization, residential/inpatient treatment, and medically managed, intensive inpatient services. The Public Behavioral Health System supports access to residential treatment across Maryland, including local residential beds, statewide beds funded by Medical Assistance, and commercial insurance provider services. Open access, same day assessments are available Monday - Saturday in Carroll County.

Issue: Community Health Services (CHS) Briefing

Background: The CHS Bureau offers programs that address current communicable disease concerns as well as other health issues affecting county residents.

1) Measles

Measles is a highly contagious viral infection that can cause serious illness and hospitalization even in healthy children. One person can infect 9 of 10 unprotected people around them, including those who are in the same room up to two hours after the infected person. Measles cases are higher in the U.S. than in previous years, but Maryland has seen only one case so far in 2024. Measles is often brought to the U.S. by residents returning from international travel, and it spreads mainly in unvaccinated populations. Community vaccination rates of 95% or higher minimize the risk of outbreaks.

2) Avian Influenza (HPAI) - H5N1

Avian influenza, or bird flu, has been found in cattle in 9 states. Human infections are rare with this current virus, with only one case identified thus far in 2024, in a dairy farm worker. MDH has issued guidance to protect farm workers. Viral fragments were found in milk, but pasteurization kills flu viruses and other pathogens. Health officials are monitoring the situation and testing the effectiveness of current vaccines and treatments. Current risk to the public is low, but if the virus changes, it could spread more easily or cause more severe illness in humans.

3) Lead exposure

Children exposed to lead can experience slower growth and development, learning and behavior problems, and brain damage. In 2015, Maryland lead poisoning risk guidelines changed to include all zip codes, and screening is now required for all children at 12 and 24 months. Lead can come from many sources including paint, water pipes, old or imported toys, spices, and dust from certain activities.

In January 2024, the threshold for elevated blood lead levels was reduced to 3.5 mcg/dl. CCHD works with families of children with elevated blood lead levels to provide education and resources, arrange follow-up testing, and set up a home inspection. CCHD has also reached out to local providers to assess lead screening capacity and provide testing equipment. A lead screening campaign including billboards, social media, and rack cards was launched in early 2024.

Issue: Environmental Health briefing on appeals process:

The Commissioners requested an overview of the appeals process for Environmental Health services. The Carroll County Health Department changed communication of our Appeals process to come into compliance with State efforts in May 2022. Our appeals process uses the standardized language developed by Maryland Department of Health and Maryland Department of the Environment. The appeal process is communicated on all food inspection forms conducted under Maryland Department of Health and included in any denials of permits or inspections under the Department of the Environment. Issue:

Briefing/Public Hearing/Possible Adoption – 2024 Spring Amendment to Water and Sewer Master Plan

Background:

The Water and Sewer Master Plan is a document that is prepared by the Department of Planning and Land Management for the purpose of delineating water and sewer service areas, identifying planned projects, and calculating water and sewer demand for the County and the eight municipal systems.

The County provides opportunities for amendments twice a year, one in the Spring and one in the Fall, to address changing conditions and circumstances. This proposed amendment focuses on changes to the Projected Water Supply Demands and Planned Capacity; the Projected Sewer Supply Demands and Projected Capacity; the Freedom/Sykesville water/sewer service area maps; the Town of Hampstead sewer service area map, the Town of Mount Airy water service area map and the City of Westminster water/sewer service area maps.

The purpose of this hearing is to accept public comment regarding the 2024 Spring Amendment to the Carroll County Water and Sewer Master Plan.

Bureau of Comprehensive Planning Ordinance Change – Adult Use Cannabis Zoning Code Briefing Paper May 16, 2024 Open Session

Adoption – Ordinance Change for Adult Use Cannabis – Text Amendments to Chapter 158 of the Zoning Code

Background:

On March 7, 2024 the Board of County Commissioners conducted a public hearing to hear comments on the proposed amendments to Chapter 158 regarding Adult Use Cannabis. The record was left open following the public hearing for a period of 10 days.

The proposed amendments to Chapter 158 will make the County's zoning code consistent with State Law and specifically will:

- Replace definitions related to Medical Cannabis with definitions related to Adult Use Cannabis,
- Establish distance requirements and other regulations cannabis facilities must adhere to, and,
- o Revise the Table of Land Uses to include Adult Use Cannabis facilities.

Exercise Option to Purchase – Rural Legacy Program Option to Purchase a conservation easement on the Gerry and Brenda Day property, Dave Rill Road, Hampstead, District 2.

Background:

A 61.787-acre farm property owned by Gerry and Brenda Day located at the above address was granted preliminary approval to participate in the Maryland Rural Legacy Program by the County Agricultural Land Preservation Advisory Board on January 4, 2023. The easement will be purchased using only state Rural Legacy Program grant funds at a direct cost of \$294,383.30. Notice of Intent to purchase a conservation easement on the property has been duly advertised.

The Option signed by the owners provides 120 days for the Commissioners to exercise the Option thereby converting it to a Contract of Sale. The Maryland Department of Natural Resources Rural Legacy Program has approved the purchase through a grant agreement with Carroll County. The County and the landowner are ready to proceed to the easement settlement stage.

The Office of Procurement in cooperation with the Bureau of Engineering request your approval to award a contract to Stambaugh's, Inc. for the Greenmount Church Rd Pipe and Headwall Replacement in the amount of \$52,370.00. Stambaugh's, Inc. is an approved term contractor that was competitively bid. This amount is within the adopted budget.

Background:

Due to heavy rains approximately half of the pipe has become misaligned, leading to severe ruts in the pavement. Roads Operations applied a temporary patch in 2022 and monitored for the past two years. Unfortunately, the condition has gradually deteriorated resulting in the need to replace the pipe and headwall.

EXECUTIVE SUMMARY:

The Office of Procurement in cooperation with the Bureau of Building Construction request your approval to award a contract to A.J. Deluca in the amount of \$85,390.00. This award will consist of two parts. The first is to clean and repaint the Alms Barn Roof and replace the gutters. Secondly, this award will be to replace the roof on the corn crib with a cedar roof. A.J. Deluca is one of the County's approved term contractors that was competitively bid. The amount is within the adopted budget.

Background:

The roof and the gutters of the Alms Barn have started to rust. To preserve the roof, all surface rust will be removed by sanders and wire wheels. The roof will be cleaned and pressure washed. The roof will then be primed and double coated with acrylic coating. All gutters and downspouts will be replaced.

The cedar roof on the Corn Crib has reached the point of a much-needed replacement. The roof and the gutters will be removed and replaced with period correct new "heavy" cedar shakes. The failing sistered rafters on the low area side of the barn will be removed and replaced with same as original rough cut lumber to better reflect the historic nature of the barn.
