Opening Statement

The meeting was called to order by Chair, Steve Miller at approximately 2:30 p.m.

The December 18, 2019 meeting summary was approved by Perry Jones, seconded by Dick Swanson and carried.

Zebra Mussels Eradication Results - Zach Neal

Zach Neal gave a presentation of the Zebra Mussels eradication at Hydes Quarry. He provided some background about Zebra and Quagga mussels, noting where they are from and what the economic and environmental consequences of them are. He summarized the County's response plan which took approximately 15 months from when they first became aware of the mussel invasion to when they were able to deal with them. He also detailed the current status since the treatment.

MS4 Workshop Direction – Brenda Dinne

Brenda stated that the Environmental Advisory Council hosts MS4 workshops each year. The first workshop for citizens took place at the Hampstead Senior Center. Only 4 people showed up. Brenda asked if the WRCC thinks there is a better direction to go. Dick Swanson stated that the Mount Airy Water and Sewer Commission has an information session at their Town Council meetings. Steve Miller asked if we could partner with the Media Center and provide short segments on cable tv. After further discussion, the consensus was to look at going in the direction of on-line meetings and utilizing social media.

Legislative Update – Brenda Dinne

Brenda said that there are no legislative concerns related to the WRCC at this time.

Municipal Stormwater Projects Update – Chris Heyn

Chris Heyn, Bureau Chief, Resource Management, provided an update on the municipal restoration projects. A copy of that report is attached.

Chris stated that sometimes he receives calls from contractors after hours, and he would like a list of contact information for a key person in each municipality. It could be the town manager, the head of the department of public works or a non-emergency department of public works contact. He requested that everyone contact Kim Dubbert, in Land and Resource Management with that information.

Other

The annual report was handed out to all municipalities.

Tom Devilbiss announced that he and Chris Heyn attended a meeting with MDE that included all permitees. MDE indicated that the large jurisdictions will get tentative permits in the summer. They did not indicate when the medium jurisdictions would get theirs. The new guidance document that came out in December 2019 is a final unless there is a flaw, and will be sent out with the tentative permits. It becomes part of the permit.

Steve Miller asked the Council members for any ideas for future agenda topics.

Brenda Dinne asked the Council members if they are interested in doing a stormwater tour in May of 2020 again. The Council responded yes and to invite the NGOs again to join the municipalities in one tour.

Tom Devilbiss reminded the Council members of the code updates with the Commissioners and that they may be opening codes up such as forestry, water resources, development review. He asked the members to let him know if they think of anything that they feel needs to be updated.

TOWN PROJECT STATUS January 22, 2020

FUTURE PROJECTS:

Locust Street (Citizens Energy) (Union Bridge) – The Town and Citizens Energy are moving forward with the project; therefore, BRM staff will be contacting Citizens Energy to continue discussions on property transfer.

Michael's Property (Hampstead) – BRM staff met with Tammi to discuss how to move forward with transferring sewer allocations to the Michaels. She will be contacting Price for additional information and then approach the property owners regarding transfers. BRM staff will schedule a meeting with the Michaels when Tammi has documentation that the property owner is willing to move forward.

Hampstead Valley Study (Hampstead) – RK&K was selected to perform a watershed study to provide water quality, reduce thermal impacts, and investigate ways to reduce or eliminate hazard classifications for existing facilities. Project will be initiated in February with results expected this spring. The Bureau is going before the Commissioners this Thursday to request permission to apply for construction grant funds for projects that are anticipated to come out of the study.

PRELIMINARY:

IDA Property (**Mt. Airy**) – Preliminary plans have been reviewed and permission given to CLSI to proceed with final plans.

FINAL:

East/West Pond (formerly Prospect Road Mt. Airy, Frederick County Side) MDE Bay Restoration FY 20 Grant \$1,000,000.00) – Final plans have been submitted to MDE for review. County staff will coordinate final County, Town, Soil Conservation, and MDE comments. Town notified BRM of their concerns relating to underground utilities.

Trevanion Terrace (MDE Bay Restoration FY 20 Grant \$325,000.00) (Taneytown) – Final plans have been submitted to MDE for review. County staff will coordinate final County, Town, Soil Conservation, and MDE comments.

Greens of Westminster Sec. 6, Pond #2 (MDE Bay Restoration FY 20 Grant \$400,000.00) (Westminster) – BRM staff has submitted final approved plans to MDE for review.

Twin Ridge (Mt. Airy – Frederick County Side) – Final plans have been approved and the project will be advertised on January 27th. BRM is finalizing permits with MDE Dam Safety.

UNDER CONSTRUCTION:

Langdon Property (City of Westminster) (DNR Grant Funds \$900,000 and SHA TAP Fund \$980,000) – HTI submitted the low bid for the project in the amount of \$1,696,300.85. The Bureau has received approval from SHA to award the contract. Currently there is an RFP out to handle the material when it arrives in New Windsor. There is also an RFP out for construction inspection and oversight to assist with the project. The three contracts will all be presented to the Board of Commissioners for approval on February 22nd. It is anticipated that HTI will begin work in March with hauling operations starting in April.

Shiloh Middle School (Town of Hampstead) – WF Delauter is actively working on the site. Minor utility work is being performed now with construction of the weir wall anticipated in the near future.

Whispering Valley (Town of Manchester) (DNR Grant Funds \$375,000.00) – All permits have been obtained. BRM staff is in the process of getting a couple remaining temporary construction easements signed and are working with the Lambert's on wrapping up the property purchase. A stabilized construction entrance has been installed and the contractor has been discussing site access with SHA.

Willow Ponds (City of Westminster) (DNR Grant Funds \$1,900,000) – Kibler was awarded the construction project in the amount of \$2,950,000.00. BRM is awaiting permits from the ACOE, and MDE. Upon receipt of this information, BRM will schedule a pre-construction meeting with Kibler to discuss the project. A stabilized construction entrance has been installed and a clay stockpile is being moved on site.

Robert's Mill (City of Taneytown) (DNR Grant Funds \$1,000,000 and CBT Grant \$75,000) – Construction continues on the bridge structure with work now progressing on the weir wall. We anticipate the concrete work will be completed in March.

Shannon Run (Town of Sykesville) (DNR Grant Funds \$600,000.00) – WF Delauter is pumping down the facility to perform the final work to install the trash rack and removal of the sediment control. CLSI needs to submit the as-built for approval.

Opening Statement

The meeting was called to order by Chair, Steve Miller at approximately 2:30 p.m.

On behalf of the WRCC, Steve Miller, Jim Wieprecht, Tom Devilbiss, and Glenn Edwards recognized Joanna Birch, NPDES Compliance Specialist for her valuable contribution and dedicated services to the WRCC. Ms. Birch is leaving County employment.

The January 22, 2020 meeting summary was approved by Jim Wieprecht, seconded by Perry Jones and carried.

Piney Run Dam Study and Temperature Mitigation Update - Chris Heyn

Chris provided an update on 2 separate projects, the Piney Run Dam Study and Temperature Mitigation. Regarding temperature mitigation, when Piney Run Dam and Reservoir was originally constructed in 1974, the County was required to meet all water quality requirements. The reservoir is in a Use III watershed so the water in the stream is supposed to support cold water species. We are not currently meeting the temperature requirements. Several years ago, MDE required that we start looking at ways to do a cold-water release. Chris detailed the steps that have been taking place to address the requirement.

Regarding the Piney Run Watershed Study, Chris explained that MDE indicated through some studies that they want the County to analyze the Piney Run Dam to make sure it meets all current compliance regulations. The County brought AECOM on board to do a watershed study. They started doing inspections and analysis in September 2019. A public meeting was held the

evening of February 25, 2020 in which AECOM made a presentation providing background on what the County is trying to accomplish. The public was invited to complete a comment card at the meeting, submit comments via e-mail to the County, or mail comments directly to the County. A Piney Run Watershed Study Fact Sheet is attached which includes the Piney Run Watershed Study Project information and timeline.

Legislative Update – Brenda Dinne

Brenda provided the Board with a handout detailing the 2020 General Assembly proposed environmental legislation. She reviewed each bill and its current status.

<u>Municipal Stormwater Projects Update – Chris Heyn</u>

Chris Heyn, Bureau Chief, Resource Management, provided an update on the municipal restoration projects. A copy of that report is attached. He also reminded the board members of the importance of maintaining the tree plantings in their municipalities.

Other

Tom Devilbiss spoke about a possible on-site meeting when the Langdon project starts. He also discussed a flood study taking place in Union Bridge. The Army Corp. of Engineers is paying for the flood study and will provide conceptual options to mitigate flooding.

Jim Wieprecht stated that the EPA is requiring Risk Assessment and Resiliency Plans. He asked if we can get a speaker from Maryland Rural Water Association.

Steve said they are looking at possibly having municipalities do testing of productions wells in regard to chloride.

FUTURE PROJECTS:

Locust Street (Citizens Energy) (Union Bridge) – An agreement between the Town and Citizens Energy is set to become final in mid-March. With the completion of that agreement, we can proceed with obtaining the needed parcel and continue moving forward with the project.

Michael's Property (Hampstead) – BRM staff met with Tammi to discuss how to move forward with transferring sewer allocations to the Michaels. She will be contacting Price for additional information and then approach the property owners regarding transfers. BRM staff will schedule a meeting with the Michaels when Tammi has documentation that the property owner is willing to move forward.

Hampstead Valley Study (Hampstead) – Staff met with RK&K in early February to walk the watershed and investigate opportunities. RK&K is in the process of working on the study. Results are expected this spring and will be shared with the group.

FINAL:

East/West Pond (formerly Prospect Road Mt. Airy, Frederick County Side) MDE Bay Restoration FY 20 Grant \$1,000,000.00) – Final plans have been submitted to MDE for review. County staff will coordinate final County, Town, Soil Conservation, and MDE comments. Town notified BRM of their concerns relating to underground utilities.

Trevanion Terrace (MDE Bay Restoration FY 20 Grant \$325,000.00) (Taneytown) – Final plans have been submitted to MDE for review. County staff will coordinate final County, Town, Soil Conservation, and MDE comments.

Greens of Westminster Sec. 6, Pond #2 (MDE Bay Restoration FY 20 Grant \$400,000.00) (Westminster) – Project is currently out for bid. Responses due back March 11th. Construction estimated to begin in May or June.

Twin Ridge (Mt. Airy – Frederick County Side) – Project has been bid and responses have been received. County staff will be discussing award with Town of Mount Airy on 2/28.

UNDER CONSTRUCTION:

Langdon Property (City of Westminster) (DNR Grant Funds \$900,000 and SHA TAP Fund \$980,000) — All required approvals to proceed have been received. Final agreements are being put in place between the County and HTI for the pond construction and with Stambaughs for the work in New Windsor. Construction expected to begin in mid-March with hauling of materials by train starting in early April.

Shiloh Middle School (Town of Hampstead) – WF Delauter is actively working on the site. Work has begun on the weir wall for the upper facility.

Whispering Valley (Town of Manchester) (DNR Grant Funds \$375,000.00) – Property has been conveyed to the County. Construction has begun.

Willow Ponds (City of Westminster) (DNR Grant Funds \$1,900,000) – All permits are in hand and construction has begun.

Robert's Mill (City of Taneytown) (DNR Grant Funds \$1,000,000 and CBT Grant \$75,000) – Construction continues on the bridge structure with work now progressing on the weir wall. We anticipate the concrete work will be completed in March.

Shannon Run (Town of Sykesville) (DNR Grant Funds \$600,000.00) – Project is complete. Some funds have been withheld to ensure vegetation establishment this spring.

Opening Statement

The virtual GoToMeeting was called to order by Chair, Steve Miller at approximately 2:30 p.m.

The February 26, 2020 meeting summary was approved by Jim Wieprecht, seconded by Kevin Hann and carried.

Overview of NPDES Large MS4 Permits – Tom Devilbiss

Tom stated that Land and Resource Management (LRM) submitted an annual report for the 4th generation permit. Draft comments received from MDE stated very little problems. Almost all the comments were positive with not a lot of pending items to address. LRM has been working since June 2016 with MDE on Restoration Plans, and they have approved all the major watershed plans. The permit ended December 2019. MDE has a draft permit for the large jurisdictions, but they have not shared. Steve Miller congratulated staff on the annual report.

Review Fee Increases – Clay Black

Clay shared that the Commissioner's recently asked Land and Resource Management to review current fees charged for residential/commercial development projects submitted to the Bureau of Development Review. These fees have not been revised for 20 years. Fees are currently being charged for review by Development Review, Engineering, Stormwater Management, Forrest Conservation, and Floodplain. Mr. Black presented a PowerPoint explaining the proposed increase in fees. The WRCC fully supports the increases.

Overview of Draft Accounting Guidance - Chris Heyn

Chris discussed the June 2020 draft MDE Accounting Guidance manual. The manual provides guidance on permit implementation and is used by MDE as an accounting mechanism. He highlighted some of the new rates and credits for new practices such as tree plantings, street sweeping, storm drain and inlet cleaning, urban soil restoration, and septic pumping. The draft document should be finalized by the end of the year.

Municipal Stormwater Projects Update - Chris Heyn

Chris Heyn, Bureau Chief, Resource Management, provided an update on the municipal restoration projects. A copy of that report is attached. He also shared pictures of the Langdon project.

Locust Street (Citizens Energy) (Union Bridge) – We hope to be moving forward with the project soon.

Michael's Property (Hampstead) – BRM staff met with Tammi to discuss how to move forward with transferring sewer allocations to the Michaels. She will be contacting Price for additional information and then approach the property owners regarding transfers. BRM staff will schedule a meeting with the Michaels when Tammi has documentation that the property owner is willing to move forward.

Hampstead Valley Study (Hampstead) – A draft report was submitted to the County on May 22nd. The County reviewed and provided comments back to RK&K. A resubmission of the report should be coming in on June 22nd. If the report is ready, the County will meet with the Town to discuss the proposed projects and begin planning for implementation.

DESIGN STAGE:

FINAL:

IDA Property (Mt. Airy) – Final plans have been reviewed and minor comments have been sent back to CLSI. We anticipate that the plans will be ready for approval when next submitted. We will then open discussions with IDA about moving forward with the project.

East/West Pond (formerly Prospect Road Mt. Airy, Frederick County Side) MDE Bay Restoration FY 20 Grant \$1,000,000.00) – Final plans have been approved. We are awaiting final permits and then approval to go out to bid from MDE. We anticipate going out to bid in July with construction beginning in September.

Trevanion Terrace (MDE Bay Restoration FY 20 Grant \$325,000.00) (**Taneytown**) – Final plans will be received from BAI by June 22nd. If plans are approved by stormwater, we will then submit to MDE for final approval to go out to bid.

Greens of Westminster Sec. 6, Pond #2 (MDE Bay Restoration FY 20 Grant \$400,000.00) (Westminster) – Project has been awarded to Kibler construction. A pre-construction meeting is scheduled for June 26th.

Twin Ridge (Mt. Airy – Frederick County Side) – Project has been awarded to Hamilton Construction. Currently we are waiting for final permit approval from MDE Dam Safety. We anticipate construction beginning soon after July 20th.

UNDER CONSTRUCTION:

Langdon Property (City of Westminster) (DNR Grant Funds \$900,000 and SHA TAP Fund \$980,000) – Construction is underway. Approximately 25,000 CY of material has been hauled by train from Westminster to New Windsor. Currently the hauling is on hold while HTI does utility work. Hauling will resume on June 29th. When the lagoon in New Windsor is full, the remainder of the material will be taken by rail to the Gullo property, just outside the Town. The contract for handling the material has been awarded to Stambaughs, who is currently handling the material at the lagoon. (See photos on last page)

Shiloh Middle School (Town of Hampstead) – WF Delauter is actively working on the site. Work is complete on the upper facility. Modifications to the lower facility are well under way.

Whispering Valley (Town of Manchester) (DNR Grant Funds \$375,000.00) – The lower facility is complete and the upper facility is close to being done. The majority of the remaining work is storm drain construction.

Willow Pond (City of Westminster) (DNR Grant Funds \$1,900,000) – Construction is wrapping up on the first phase of work which includes the construction of the weir wall, the diversion wall, and mass grading of the pond. Phase 2 will begin in July with the stream restoration work.

Robert's Mill (City of Taneytown) (DNR Grant Funds \$1,000,000 and CBT Grant \$75,000) – The bridge structure is complete and the mass grading of the facility is complete. The majority of the storm drain work is complete. Remaining to be done is fine grading, top soil, planting, and paving of the bridge approaches.

Shannon Run (Town of Sykesville) (DNR Grant Funds \$600,000.00) – Project is complete. The County is proposing a tree planting project on some of the open space that is remaining around the Shannon Run facility.

Opening Statement

The August 26, 2020 meeting was held at Christmas Tree Park in Manchester, Maryland. The meeting was called to order by Chair, Steve Miller at approximately 2:30 p.m. Steve thanked all present for working through these difficult times with COVID 19. He shared a history of Christmas Tree Park.

The June 24, 2020 meeting summary was approved by Jim Wieprecht, seconded by Dick Swanson and carried. The Closed Session meeting summary of June 24, 2020 was approved by Kevin Hann, seconded by Jim Wieprecht and carried.

Election of Chair and Vice-Chair

Dick Swanson motioned to nominate Steve Miller as Chair of the WRCC. The motion was seconded by Kevin Hann and carried. Kevin Hann motioned to nominate Jim Wieprecht as Vice-Chair of the WRCC. The motion was seconded by Richard Brace and carried.

Westminster Water Reuse Pilot Project Design – Jeff Glass

Jeff Glass introduced Westminster's Water Reuse Pilot Project. He stated that there is not an abundance of water in Westminster. He became interested in water reuse 15 years ago. He explained the indirect potable reuse process and the direct potable reuse process. Jeff explained details of the Pilot Program to include the Pilot Study Process Schematic.

<u>Tentative Permits for Large Phase 1 MS4 Jurisdictions – Tom Devilbiss and Chris Heyn</u>

Tom Devilbiss explained that Carroll County's MS4 Permit will be structurally identical to permits for the large jurisdictions. The EPA is reviewing the draft permit for the last time. The tentative determination should go out by the end of September, with the final permit being issued

by the end of the year. He shared that MDE's review of Carroll County's 2019 Annual Report was the best evaluation every received with few questionable items. Total compliance was achieved.

Tom announced that a new employee, Claire Hirt, will be starting with Land and Resource Management on September 17th. Claire's position will be NPDES Compliance Specialist.

Chris Heyn explained more details about the draft MS4 permit for the large jurisdictions.

Expanded Polystyrene (EPS) Ban Brochure – Brenda Dinne

Brenda Dinne explained that the State passed legislation prohibiting businesses from selling certain EPS food service products in Maryland effective July 1, 2020. Effective October 1, 2020, businesses are prohibited from using EPS products for food service. The County Commissioners asked the Environmental Advisory Council to create an informational brochure for the public. Brenda distributed that brochure to the Council members.

Municipal Stormwater Projects Update – Chris Heyn

Chris Heyn, Bureau Chief, Resource Management, provided an update on the municipal restoration projects. A copy of that report is attached.

NPDES MS4 Permit Public Education and Outreach – Glenn Edwards

Glenn Edwards thanked the Council members for returning their annual report questionnaire. He thanked Brenda Dinne for writing the Public Outreach Plan for the annual report. Glenn mentioned the County's NPDES "Protecting Carroll County Waters" webpage was being updated as a more user-friendly Public Education and Outreach "hub" for the MS4 Permit. The webpage will also include the "Stormwater Hotline". Once set, updated links will be emailed out to all municipalities for updating their sites to meet minimum MS4 compliance. Glenn encouraged all to review their websites to ensure the citizens can readily find the information online especially due to COVID 19.

He also spoke about the annual NPDES Compliance Training Workshop to be held November 6, 2020 at the Carroll County Public Safety Training Center. At this time, the workshop is planned to be "in-person" while observing COVID 19 protocols. Glenn sent out an email invite to the workshop on August 25th.

Hampstead Valley Study (Hampstead) – The watershed study prepared by RK&K recommended five potential projects in the watershed. BRM submitted grant applications to NFWF for three of the projects. One application was accepted, so BRM will discuss design options with the Town for the retrofit of the Roberts Field wet facility. BRM also submitted a grant application to the Chesapeake Bay Trust for design of a fourth facility. We will get results of that application in December.

Trevanion Terrace (MDE Bay Restoration FY 20 Grant \$325,000.00)

(**Taneytown**) – MDE has performed a final review of the plans and they are ready to approve them once all other approvals have been obtained. There are a handful of minor comments that BAI needs to address. We hope to have approval from MDE to go out to bid in October.

UNDER CONSTRUCTION:

Greens of Westminster Sec. 6, Pond #2 (MDE Bay Restoration FY 20 Grant \$363,724) (Westminster) – Project is under construction. First phase is relocation of a sanitary sewer line. Some issues with bedrock have been encountered but we are making progress.

Langdon Property (City of Westminster) (DNR Grant Funds \$900,000 and SHA TAP Fund \$980,000) – Construction is underway. Approximately 55,000 CY of material has been hauled by train from Westminster to New Windsor. Currently the hauling is on hold while HTI constructs the retaining wall. Hauling will resume on August 31st. A couple of final loads of material will go to the lagoon, but then the remainder of the material will be hauled to the Gullo property, just outside of Town. The contract for handling the material has been awarded to Stambaughs, who is currently handling the material at the lagoon.

Shiloh Middle School (Town of Hampstead) – Project is substantially complete.

Whispering Valley (Town of Manchester) (DNR Grant Funds \$375,000.00) – The project is substantially complete.

Willow Pond (City of Westminster) (DNR Grant Funds \$1,900,000) – Construction is actively occurring on the construction of the new stream floodplain. When that is complete, phase 3 will begin, which is the remainder of the pond excavation.

Robert's Mill (City of Taneytown) (DNR Grant Funds \$1,000,000 and CBT Grant \$75,000) – Project is substantially complete. A planting contractor will be coming in this fall to plant around the perimeter of the wet pond.

Twin Ridge (Mt. Airy – Frederick County Side) – Project has been awarded to Hamilton Construction. Construction has begun with installation of sediment control devices. A planting RFP for the wetland will be released soon.
