Notice of this meeting was provided to the public by mailing notice to members of the Carroll County Electrical Board and posting notice electronically on the County's website.

CALL TO ORDER:

Meeting was called to order at 9:45 a.m. by Chairman Paul Noyes at Carroll County Office Building, Permits Conference Room.

The minutes of March 26, 2019 was emailed to each board member. Mr. Noyes asked the board if everyone had read the minutes and had any changes. Mr. Brosenne made a motion to approve the minutes as written. Mr. Sullivan seconded the motion and was unanimously carried by the Board.

OLD BUSINESS:

Mr. Noyes asked if everyone had read the email defining the work "Minor" regarding the submission of electrical applications. Mr. Noyes asked if there were any concerns or questions.

Mr. Green asked Mr. Zepp how the comparison of electric work was with the homeowners submitting an electrical application without taking the exam opposed to taking the electrical exam. Mr. Zepp stated it was better with the examination; those citizens are a little more knowledgeable.

Mr. Brosenne made a motion to approve the definition of "Minor". Mr. Coppersmith seconded the motion and was unanimously carried by the Board.

NEW BUSINESS:

The Board received a letter from Mr. Roger Wentz regarding renewing his Carroll County Master Electrical license. Mr. Wentz obtained his Carroll County license by examination with Carroll County in 2003. Mr. Wentz allowed his Carroll County license to expire on

June 30, 2017. The by-laws states that a "county electrical license which has been allowed to expire for a period of one year or more shall not be reissued until an examination has been successfully taken and approval given for the reissuance of the said license". Mr. Wentz will need to take the master electrical exam again. A certified letter was sent to Mr. Wentz on February 25, 2019.

EXAM:

The meeting was reconvened at 1:00 P.M. to grade the Master Electrical Exam. The Board graded the exam. The required score to pass the exam is 70%. None of the applicants passed the Master's Exam. Their scores are as follows:

The next meeting will held on Wednesday, August 21, 2019, at Carroll County Office Building to select questions for the next electrical licensing exam #95, which will be given on Wednesday, October 23, 2019. Mr. Brosenne made a motion to adjourn the meeting. Mr. Sullivan seconded the motion and was unanimously carried by the Board.
