1. Welcome – Celene Steckel

a. Community Partners Introductions and Announcements

2. Approval of November Meeting Minutes

- a. Scott Yard motion to approve, seconded by Victoria Parks
- **b.** minutes approved, no opposition

3. Outreach Update – Judi Nance

- a. Planning spring Resource Fair in Taneytown and brainstorming additional pop ups in 2024
- b. Working with NESAP for having a Resource Fair pop-up event in the Spring
- c. Judi is transitioning to a case manager at the shelters, but will remain co-chair of the Outreach Committee

d. New hire for her position is Shannon McHale; Judi will share contact information with Jason to share with the Circle

4. Shelter Services – Joanna Waters and Samantha Garcia

- a. Night by Night 70 individuals served in December, 2 moved out into permanent housing; 6 moved to Adult Only shelter; no needs-based list
- **b.** Adult Only 45 individuals served in December, 36 capacity; 50% of our movers moved out into Permanent Housing destinations; 20 individuals on needs-based list
- c. Family Shelter served 23 individuals; 12 adults and 11 children, 8 households; 50% capacity; had 3 different families move out and 1 family move out into a perm housing destination

5. Domestic Violence in December– Springboard, Ashley Stahl

- **a.** 20 children served: 9 female adults, no males
- **b.** Average length of services was 45 days; changed from a mandatory 60 day stay
- **c.** All families were adopted for the holidays
- **d.** Not accepting clothing donations, but are accepting food donations for their pantry
- e. Two new clinical groups starting goes off insurance and need a referral
 - 1. Adult Trauma Group starting January 24 on every Wednesday from 12-1pm for 10 weeks with one week off in March for spring break; clinical psycho educational based group for adult women who have experienced trauma with PTSD and/or substance abuse
 - 2. Youth Trauma Group starting January 25 on every Thursday from 4-5pm; clinical psycho educational based group designed to help teens process and heal from trauma
- f. Most patents are in Carroll County; 1 out of county; all housed onsite and not in hotels in past 30 days
- **g.** Call mainline to donate food and/or hot meals

6. Citizen Services Update – Celene Steckel

- **a.** Aging Bobbie Lawrence
 - 1. Kathy Wood retired on December 28th; still fully staffed
 - 2. Finished up open enrollment and served over 500 individuals
 - 3. Grandparents Conference Day March 23rd, flyer coming out soon
- **b.** Housing Danielle Yates
 - 1. Carly Long is our new HMIS specialist
 - 2. PIT count on January 24th of sheltered count; unsheltered is only for odd numbered years
 - 3. Westminster City Housing Authority has closed their waitlist; Carroll County's waitlist is open
 - 4. Expungement Day January 24th flyer coming out soon from 9am-5pm to help individuals in expunging their records
 - 5. When you are awarded your housing choice voucher you cannot port for the 1st year unless you have a reasonable accommodation request

- c. Family Shelter Relocation Project Celene Steckel
 - 1. Still moving forward and working with vendor
 - 2. Applied for permits, and applying for grant funding
- **d.** Housing Study Update
 - 1. Launch meeting upcoming with Mosaic, vendor who is conducting the Housing study

7. Health Department Update – Amy Baker

- a. 988 information on the back table to take; put information on your outgoing email signature
- **b.** Received 38 calls from Carroll County last month
- c. When people aren't eligible for case management support you can apply for peer support which is recovery oriented; CCHD has 5 peers and is hiring 1 more
- d. Mike Clavin is with PATH; Garnell is peer support person who works with Mike; Jermaine Thornton is the peer supervisor
- e. Peer support is a low barrier service to help support people in their journeys of recovery
- f. Prevention team Nicotine Cessation for people who want to quit smoking

- **b.** Still awaiting feedback from our application
- c. Trying to identify what trainings we need to have
- d. Ongoing planning for a Homelessness 101 at Carroll Community College

9. Data Committee Update- Danielle Yates

- **a.** Met last week, digging into Coordinated Entry data
- **b.** Longest length of stay in shelter is our families
- c. Larger population of older adults that we are helping with homelessness

10. Youth Updates – Ed Singer

- **a.** Youth Homelessness Sub Committee will meet quarterly, next meeting is tomorrow January 10th at 10am; if interested in being on the committee see Ed; tomorrow is a presentation from Workforce Development
- **b.** Youth Action Board not made a lot of progress on this front; trying to reinvigorate; communication has not been really good; scheduled a meeting with other partners to assist
- **c.** Coordinated Community Supports Partnership Grant application submitted in December; 4 LMBs applied; applied to be a Hub to manage spokes who provide services
- d. CCPSS Youth Services Kathi Green
 - 1. 131 homeless students identified, 30% increase month to month this school year
 - 2. American Rescue Plan funds still available until September 2024 provides bedding, school-based fees, application

fees for colleges, still doing some emergent hotel stays of up to 7 nights

- 3. Families lacking the most basic needs
- 4. Unaccompanied youth any school aged child who is not living with their parent or legal guardian; all unaccompanied youth this year are housed

a. Sleep in Heavenly Peace – build beddings for those in need non-profit based in Frederick; trying to coordinate having a Carroll County build day; we need a fund-raising arm that will help support this initiative and someone that would like to participate in building beds in Frederick
