1. Welcome and Introductions

• Cathy Baker – April 20th is a Prescription medicine Take Back Event

2. Approval of the February 26th Minutes

- Scott Yard motions to approve
- Stephanie Halley seconded
- Minutes approved without objection

3. Shelter Utilization Report

- Adult Only steady flow of participants coming and going; no openings
- NbN average 40 people; have seen a surge in violent behavior and mental health; drug use and heavy drinking behaviors have also returned → Spring has come early
- Family Shelter had one new family move in
- Perm Supportive Housing no openings right now; maybe have some by 1st quarter of the year
- Westminster Rescue Mission to come in to shelter and promote recovery in the future
- A CCHD peer, Rickey Pauley is visiting the shelter during the week to assist
- Tammy Black says there is still Behavioral Health needs funding that can be utilized
- Kevin McGinnis stated there has been an influx in mental health calls and up 20% in calls; 4 suicides in the last month
- Ed Singer is working with the youth in these instances; Amy Baker through LVN working on Columbia Life House Project
- Celene and Gina with Commission Rothstein are visiting the Resiliency Center at Fort Meade
- Corey Hardinger said there is Postvention services for suicide available at CCYSB

4. Encampment behind the Health Department

- Kevin McGinnis reached out to the property owner last year who has since moved to London, England, and served trespass notices to the people in the encampment
- We need to get a map together of all the encampments behind the health department
- One person in the encampment got her voucher
- These individuals can be in shelter, but choose not to be
- Need to compose a letter giving them a date of 3 weeks to vacate
- The last letter gave 20 days and was signed by Sue Doyle and Celene Steckel

5. Subcommittee Development Discussion

- Jason to schedule a meeting with Amy and Stephanie to discuss the Lived Homelessness Subcommittee
- Lived Homelessness Subcommittee Amy Baker
 - i. Initial meeting to be held on April 9th at 1pm at the CCHD
- Advocacy Subcommittee looking at legislative impact and review bills
 - i. Chairperson searching for a steering member that could guide committee
 - ii. Members Jacqueline Spielman and Judi Nance
 - iii. Suggestion made that someone should chair the committee that does not include "our" agencies

- i. Hired a consultant, Mosaic; participated in the launch of a Housing Study surveying the public with focus groups, mini town halls; getting data on housing needs

 - Identify current housing stock and population in need of housing

 - Disabilities, youth, and homeless sub populations
